About the Workshop

This course will introduce the SCERTS model, a comprehensive, multidisciplinary educational approach designed for children with Autism Spectrum Disorders (ASD), and how to implement SCERTS Activity Planning Grids across activities and natural routines across a The SCERTS model was designed to child's day. provide guidelines for helping children progress through the stages of becoming a competent social communicator. It was also designed to provide families and educational teams with the help they may need to feel successful in supporting the child. Families, therapists, and educational teams will learn about essential interpersonal modifications, environmental arrangement, and visual supports and how they can be embedded in natural, functional and meaningful contexts. Video case examples will be used to illustrate how educators, clinicians, and families can directly apply learning strategies in the classroom environment and across settings and develop educational programming using the SCERTS practice principles. Participants will be actively engaged in problem solving how to determine goals and how to select transactional supports in these circumstances.

Learner Outcomes

Participants will be able to:

- 1. Describe essential components of a comprehensive educational program for children with Autism Spectrum Disorders (ASD)
- 2. Describe core challenges in socialcommunication and emotional regulation faced by children with ASD at different stages of development.
- 3. Identify appropriate learning and educational accommodations for children with ASD.
- Identify how the SCERTS curriculum-based assessment can be used to guide the development of IEP objectives and to design and implement educational programming to meet goals & objectives, including examples of strategies used.
- 5. Identify essential environmental modifications and interpersonal supports for preventing behaviors that interfere with learning and social engagement.
- 6. Identify essential practices for effective implementation of a multidisciplinary team educational approach for children with ASD.

She has also served as an instructor for the Communication Sciences and Disorders Department of Emerson College in Boston, Massachusetts where she has developed courses to prepare graduate level students for addressing the needs of children with autism and their



families. Her publications have focused on early identification of autism, contemporary intervention models, and programming guidelines for high functioning autism and Asperger's Syndrome. She recently participated as a member of the American Speech-Language-Hearing Association's Ad Hoc Committee on Autism Spectrum Disorders (ASD), a committee charged with developing guidelines related to the role of speech-language pathologists in the diagnosis, assessment, and treatment of ASD. She lectures internationally and provides consultation to educational programs serving children and adolescents with autism and related developmental disorders.
